Please note: The minimum loan amount is **£50,000**, unless otherwise stated.

- 1 Early Repayment Charges apply during the product term. If your client needs to add or remove a name on the mortgage they must appoint their own solicitors, in which case they will receive £250 cashback towards their costs.
- 5 Clients must nominate their own solicitor but will receive £250 cashback from the Society towards their legal fee costs.
